### **TERMS AND CONDITIONS**

This legal notice applies to the entire contents of the Website under the domain name <http://www.g3g.com> ("the Website") and to any correspondence by e-mail between us and you. Please read these terms carefully before using the Website. Using the Website indicates that you accept these terms regardless of whether or not you choose to register with us. If you do not accept these terms, please do not use the Website.

This notice is issued by G3G (UK) Ltd ("the Company").

### **1. Introduction**

1.1. You may access most areas of the Website without registering your details with us. Certain areas of the Website are only open to you if you register.
